**Contract for becoming a One Day – The One Command®
Certified Facilitator (6 Pages)**

This licensing agreement must be signed and the rules, procedures and information outlined in the following paragraphs must be complied with and followed in order for the undersigned to have any connection, implied or otherwise, with Asara Lovejoy, DBA The One Command Global Corporation, here in known as the First Party and the One Command Certified Facilitator signing below as the Second party. This contract includes, but is not limited to, certification of the undersigned to teach The One Day – The One Command®, under the following conditions.

1. Agreement to teach in the right manner. I, the Second Party agree to keep and/or teach all of the processes, techniques, exercises, material and information as outlined in The One Day –The One Command® Seminar Facilitator's and Student's Manual exactly as presented in the Manuals.
2. Integrity of the material. I, the Second Party agree that the integrity of the teachings described in paragraph 1 above will not be knowingly or intentionally distorted, added to, changed, modified, or 'improved' upon. Any and all processes ® © ™ in The One Command® student and teachers manuals are the exclusive property of the First Party and cannot be duplicated or claimed to be anything other than the exclusive property of the First Party. The material may be applied to teaching, educating and to the practice of The One Command® with permission.
3. Separate Practice. If I, the Second Party, teach a class or seminar concerning another established or unestablished modality, I understand that the teachings of The One Command® as outlined by the First Party are to be taught as a separate entity. Therefore, I understand that if I teach The Teachings of The One Command® with another established or unestablished modality, it shall be cause for immediate termination of this licensing agreement between the First Party and the Second Party.
4. Permission to Include. I have the express permission by the First Party to teach the Six-Step process and the One Command within the framework as a tool for transformation in my coaching and educational businesses and engagement with an audience for a specific purpose. I may not represent this as the complete and full teaching or issue a certification with this application.
5. Copyright rights. I further agree not to in any form or manner, reproduce, copy, duplicate, transmit into electronic form or adapt any written or illustrated material associated with the original processes, techniques, exercises, material and information from the book The One Command®, The Teachings of The One Command® in any

written, CD or electronic form without written consent from the First Party. I, the undersigned, also understand that the aforementioned book is copyrighted and all processes in this book and the manual are trademarked as protected by law.

6. Materials Provided. The first party agrees to provide the following materials: manuals, outlines, handouts, power point presentations and hour by hour timing of where you should be in the teaching and on what subject. I agree to adhere to this form or presentation and if lacking the skills for this presentation to attend training provided by the organization to learn this method.
7. Ethics and Standards.

Section 7.1. I agree to adhere to the Code of Ethics of The One Command Organization (herein known as the Organization) as explained in **addendum A** and to follow all the rules of contact, and communication to the Organization and within the Organization and adhere to the arbitration, solutions, and recourse for any One Command business, operations, marketing, promotions, affiliate engagement, statements, and any issue not mentioned but specifically relating to the business and operations of The One Command.

Section 7.2 As a Certified **The One Day - One Command®** Certified Facilitator I agree to act in an ethical and professional manner, with integrity when working with all clients and students. The undersigned understands that any unprofessional or unethical behavior with clients in the course of teaching a class or seminar shall be cause for termination of this licensing agreement.

Section 7.3 I agree to hand out a feedback questionnaire in every course, have the students fill it out and submit it to the One Command Organization with the names of those who attended as referred to in section (13).

Section 7.4 If there are more than three complaints or even one serious complaint about The Second Party from clients or attendees in the seminars received by First Party that prove to be accurate and true, the consequences of those complaints will be handled in the following manner.

- 1: A notice to stop, cease and desist teaching or engaging in the work of the One Command until remedied.
2. A clear remedy will be offered and provided by The First Party such as coaching, and additional training to be paid for by The Second Party.

Section 7.5 If these remedies are disregarded and actions to remedy not taken it shall be cause for immediate termination of this contract between the First Party and the Second Party with all rights of Second Party to represent themselves as a Leader Coach or One Command Facilitator or teacher of The One Command and the use of any and all of the materials will be withdrawn with penalty under the law.

Section 7.6. Arbitration. In the event of a dispute between First and Second Party on any part of this agreement both parties agree to arbitration for resolution. Such dispute shall be referred to binding private arbitration in Seattle, WA, in accordance with the Rules of the American Arbitration Association, and any arbitration award shall be fully enforceable as a judgment in any court of competent jurisdiction. Notwithstanding the foregoing, the parties shall have the right to conduct reasonable discovery as permitted by the arbitrator(s).

8. Not hold liable. I will not hold Asara Lovejoy or any member, employee, associate, and/or contracted worker of The One Command Global Corporation, liable for any adverse effects derived from the use of these processes.
9. Not claim partnership. I will not claim partnership with Asara Lovejoy, The One Command Global Corporation, unless a separate partnership, Limited partnership or joint venture agreement has been made between both parties.
10. Updating your Materials. The undersigned is aware that The One Command course and seminar information and materials of the First Party are continuously being updated and as a certified Facilitator of The One Command method, the undersigned is required to be knowledgeable and keep current with the updated information, materials and techniques. The First Party agrees to provide such updates as they occur and to provide recertification with those materials. The undersigned understands that if he/she does not recertify then it shall be cause for termination of this licensing agreement between the First Party and the undersigned and no longer has rights to any of the materials provided during the certification process – to use them or apply them in any way.
11. Action upon notification. Upon notification of updated Seminar Facilitator manuals, student manuals and materials, I agree to purchase them in a timely manner if a fee is required. I understand that the First Parties seminars are continuously updated and it is necessary to keep up with the new information by purchasing any new manuals. If I do not purchase the new manuals and teach the information as contained in the new manuals, it shall be cause for immediate termination of this licensing agreement between the First Party and the undersigned.
12. One Command Book purchase. The Seminar Leaders may purchase The One Command book from Berkley division of Penguin publishing at a negotiated rate for leaders.
13. Student Records. Second Party agrees to send the First Party **the names of all students taught in each and every Teachings of The One Command® seminars**. This includes the student's name, address, telephone number and email address. This qualifies students to progress in The One Command® Leadership, Mentoring and Coaching certification process and connect them into the larger One Command community.

14. I agree to have those attending my One Day –One Command seminar to fill out a form to send to The One Command Organization stating that the purpose is to add them to our student roster; ie. Name, address, phone and email address.
15. Not Teaching Leaders. I agree NOT to hold, instruct, teach or claim to be teaching others to become a Certified One-Day One Command Facilitator. The Seminar Facilitators and Leaders Certification classes are taught only by Asara Lovejoy or her approved teachers and includes, but is not limited to, information from Asara’s book The One Command® and Asara’s Seminar Leaders manual.
16. Renew Certification. The undersigned agrees to renew and recertify their Seminar Facilitators Certification every two-years by attending a One Command Leadership training course or its equivalent provided by the First Party. This recertification is to keep in compliance with new materials and teachings of The One Command. 30 CEU (continuing Education Units) will be provided for recertification. Recertification should be completed by December 30, 2015.

18. Entire Agreement. This Agreement is the entire agreement between the parties with respect to the subject matter hereof and supersedes any prior agreement or understanding pertaining to the subject matter herein. This agreement may be amended only by a written instrument executed by both parties. If any part of this Agreement shall be invalid or unenforceable, such invalidity or unenforceability shall not affect the balance of this Agreement
19. Future Agreements. This agreement has absolutely no bearing on any future promotions or joint ventures that First and Second parties choose to enter into. Such ventures will be negotiated separately and applicable terms will be applied with a new agreement.
